## Question 7

### SOURCE 1

#### Female representation in UK politics

Despite females making up nearly 51% of the UK population they remain underrepresented in UK politics. A 2019 report ranked the UK 39<sup>th</sup> out of 190 countries when it comes to parliamentary equality. Parliamentary equality means that the proportion of women in a national parliament is equal to their numbers in the general population.

Although women have yet to achieve fair representation, they do account for a healthy proportion of representatives in the House of Commons. Current levels of female representation in the House of Commons have seen a big improvement since the 1992 UK general election when women accounted for less than 10% of elected representatives. However, a worrying trend that will have an impact on female representation in the House of Commons is the number of women MPs who made the choice not to run for re-election in the 2019 UK general election, stating vicious online abuse and intimidation as the reasons for stepping down. Meanwhile, campaign groups such as '50:50 Parliament' continue the fight for female equality in parliament.

There are also promising signs of fairer representation in the devolved institutions of the UK. All of the devolved institutions have demonstrated gains over the last twenty years in female representation and in the Scottish Parliament, three out of the four main political parties have been led by women.

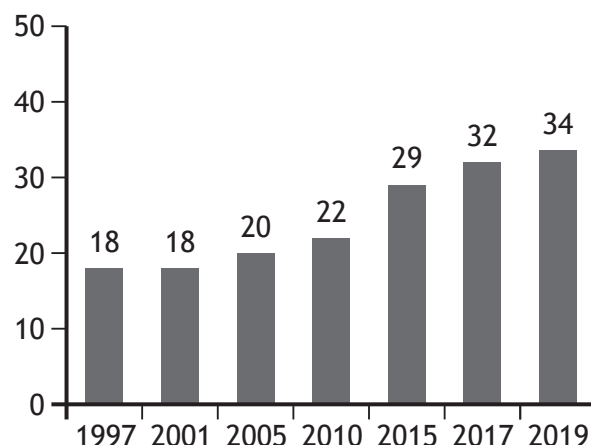

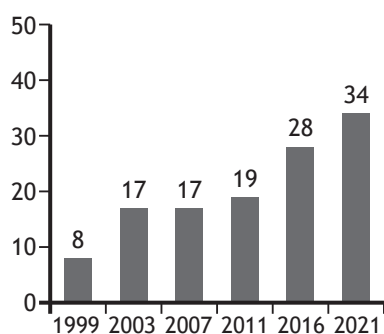

Female MPs elected to the House of Commons at UK general elections (%)

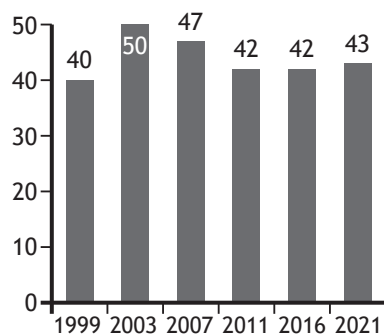


Female representation in the UK devolved institutions (%)

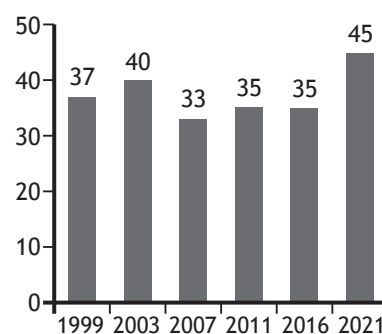

#### Physical Activity Labelling

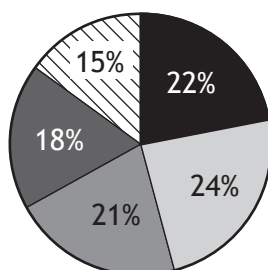
Each year the UK spends £47 billion on the treatment of obesity which is a burden on the NHS. Physical Activity Labelling (PAL) would be one way of improving overall health by encouraging a reduction in calorie intake. PAL would be a small symbol showing how much exercise is required to burn off the calories contained in food and drink. This strategy could be used on packaging, supermarket labels and restaurant menus. It could be a way to reduce overeating or encourage people to exercise more to burn off the calories they have consumed. In restaurants and coffee shops, where people eat most of their high-calorie foods, there is usually limited labelling. A recent study indicates that there is support for the introduction of PAL and that people asked thought it might change their behaviour.

However, an international study in 2020 reported no significant reduction in calories from PAL. It is widely known that people spend very little time looking at food packaging before deciding whether to buy it or not. All pre-packed food requires a food label that displays certain information and all labelling must be accurate and not misleading. PAL could prove confusing alongside this existing labelling. Experts have suggested that a 'snack tax' on biscuits, cakes, chocolates and sweets would be more likely than PAL to change consumer purchasing and tackle obesity. Furthermore, around two thirds of adults in the UK take regular exercise as a way of keeping healthy.

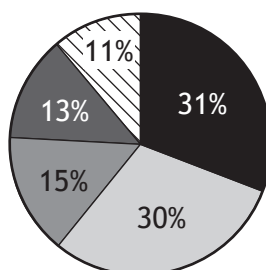

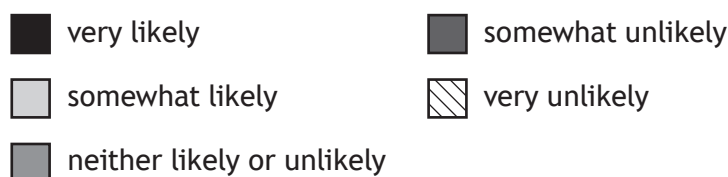
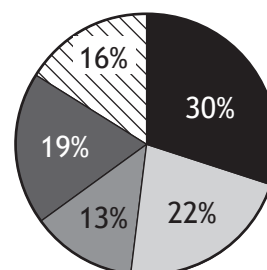

#### **Education**

I will ensure increased funding for schools and libraries, and enhance digital technologies. Education has been an area that has been neglected for years.

#### **Transport**

Harsh winters and recent flooding have caused major problems to our roads. Under my government we will re-route roads and resurface them to improve the network.

#### **Other aims**

I will look to increase tourism to pre COVID-19 levels given how important it is to the Florin economy. Too few young people in Florin stay on in high school and I aim to change this. I also plan to ensure more medical staff are recruited in order to deal with hospital shortages.

# FLORIN NEWS

## ***What's happening in the province?***

Florin's industry is changing as thousands of adults are no longer employed in the traditional industries of forestry and fishing. New industries are taking their place. Over 15,000 people now work in the film and TV industry and companies are keen to employ more young people.

Tourism is a vital to Florin and normally contributes over one billion dollars to the economy each year. However, due to the COVID-19 pandemic, revenue from tourism has more than halved as less tourists are visiting Florin. Businesses are now calling on the Florin government to do more to support tourism.

Andacia is viewed very positively abroad but several provinces, including Florin, need to do more to be seen as an equal society. The province still has laws that do not promote equality for the LGBTQ community. Campaigners have recently been protesting around the law that denies same-sex marriage.

Climate change is having an impact on the road network within the province with several roads virtually washed away this year. This was due to heavy rain combined with more snow melt than usual. Environmental pressure groups are also promoting greater use of alternative green energy sources such as wind and wave power.

Florin's government is known to heavily invest in education. In recent months all young people in school have been issued with their own digital device to enhance their learning experience.
