General Marking Principles for National 5 Religious, Moral and Philosophical Studies

This information is provided to help you understand the general principles you must apply when marking candidate responses to questions in this Paper. These principles must be read in conjunction with the detailed marking instructions, which identify the key features required in candidate responses.

- (a) Marks for each candidate response must always be assigned in line with these General Marking Principles and the Detailed Marking Instructions for this assessment.
- (b) Marking should always be positive. This means that, for each candidate response, marks are accumulated for the demonstration of relevant skills, knowledge and understanding: they are not deducted from a maximum on the basis of errors or omissions.
- (c) In this question paper the following question types are used:
 - Describe . . .

"Describe" questions require candidates to make relevant factual points. These may be either a number of separate points or a single point which is developed. These should be key points but may not be connected.

- Explain . . . / what reasons might there be for . . ?

 "Explain" questions require candidates to make points that clarify the issue or question involved. These should be key points and may include reference to relevant abstract ideas, although these need not be fully explained.
- Do you agree? / Would people agree with . . ? / Should people accept . . ? / Is it true that . . ? Give reasons for your answer.

These types of questions require candidates to give a relevant point of view/justification/assessment of a given statement. The candidate may fully agree, fully disagree or make points on both sides. All are equally acceptable as a route to full marks. Candidates may answer from their own perspective or belief, apply a perspective or belief held by others, or combine these. All are acceptable as a route to full marks.

- (d) Award 1 mark for a clear and relevant statement, description, reason or explanation.
 - Where the point is developed, eg by offering further detail, additional explanation or example, award a second mark.
 - A very well developed point may be awarded up to 4 marks.
 - A maximum of 1 mark should be awarded for an unexplained list.
 - Candidates may offer a one or two sided evaluation for full marks.
 - No marks for simply stating a personal opinion in evaluation questions. Marks should be awarded for reasons.
 - KU used to support an evaluative point should be credited.

Where the point is developed, eg by offering further detail, additional explanation or example, award a second mark. A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Life of Buddha helps them to understand the Dhamma (1 mark). His leaving the palace and becoming a wandering holy shows the importance of searching for 'the truth' (1 mark). The 4 sights help them to understand The 3 Marks of Existence - Anicca, Anatta, and Dukkha (1 mark). The Buddha living a life of luxury, then a life of suffering with the ascetics, then finding the middle way helps them to understand the path of Buddhism (2 marks). The Buddha's enlightenment shows them that their own efforts can help them escape suffering (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

It is the teachings of the Buddha so helps them to understand the truth about reality (1 mark). It helps Buddhists to achieve the middle way between 2 extremes (1 mark). It helps them gain positive kamma (1 mark) which helps them to progress towards Nibbana (1 mark). It helps them lead a moral life (1 mark). It helps them to develop the virtue of compassion (1 mark). It helps them to recognise the need for effort on the path to enlightenment (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

A maximum of 1 mark should be awarded for an unexplained list. 		 Responses could include: 1. Right view - accepting the Buddha's analysis of human existence (1 mark), accept the 4 Noble Truths (1 mark). Without acceptance the rest of the path is pointless (1 mark). 2. Right intention - seeing one's goal as enlightenment (1 mark) and unselfish love of all beings (1 mark). 3. Right speech - Abstaining from lying (1 mark), from divisive speech (1 mark), from abusive speech (1 mark), and from idle chatter (1 mark). 4. Right action - refers to the basic moral code of Buddhism (1 mark). This can be explained by referring to the 5 precepts (1 mark). 5. Right livelihood - that means being honest and ethical in business dealings (1 mark), not to cheat, lie or steal (1 mark), should be beneficial (1 mark). 6. Right effort - being aware of good and bad factors in your personality (1 mark) and working towards eliminating the negative (1 mark) and accentuating the positive (1 mark). 7. Right mindfulness - deliberate cultivation of calm and awareness especially with your own thoughts and feelings (1 mark). The view is to have more control over them (1 mark). 8. Right concentration - formal meditation, the practice of techniques designed to lead the mind into states achieved by the Buddha (1 mark). Accept 4 Noble Truths (1 mark). Award marks where candidates discuss the three parts of the eightfold path: wisdom, morality, meditation. Award marks for any other valid point, in accordance with General Marking Instructions. Max. 3 marks if only one step is described.

A maximum of 1 mark should be awarded for an unexplained list. Candidates may offer a one or two sided evaluation for full marks. No marks for simply stating a personal opinion in evaluation questions. Marks should be awarded for reasons. KU used to support an evaluative point should be credited. 		 Yes It can be hard to follow the Eightfold Path correctly without expert guidance due to emphasis on wisdom and the need to study scripture (especially in the Theravada) (2 marks). It is not always easy to do the right thing, eg tempted into wrong action, or to gossip (wrong speech), etc (2 marks). Meditation is difficult to master on your own (1 mark). In Theravada Buddhism you need to become a monk in order to address the Eightfold Path successfully (1 mark). The distractions of a modern consumer society make it very difficult to focus on detachment (1 mark). People are bombarded with temptations through TV and media (1 mark). Having a busy life can make it difficult to follow the steps eg job and family (1 mark). Candidates should be credited with marks for attempting to address specific steps eg Right Livelihood and an explanation of why it might be difficult to always avoid harm.
			 Gives easy step by step guidance for progress (1 mark). The Buddha taught that the Eightfold Path should be followed on an individual basis and should not be looked upon as rules to be followed lavishly (1 mark). Could be easier within Mahayanan Buddhism as they are more flexible and can adapt to everyday life whereas Therevadan Buddhists can be more strict (2 marks). The more you practise the Eightfold Path the easier it becomes. Monastic Buddhists can find it easy to devote their lives to the Eightfold Path (1 mark). The solitary life of the monk can easily find space and quiet for mindfulness (1 mark). They don't have the distractions of a modern consumer society and the stresses of everyday life (1 mark).

A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Pivinely inspired therefore trustworthy source (1 mark). They reveal to Christians the nature of God and Jesus (1 mark). They contain the teachings of Jesus (1 mark). They are a biographical account of Jesus (1 mark) and through them Christians become closer to Jesus and God (1 mark). They are a source of moral guidance (1 mark). They are a source of spiritual guidance (1 mark). Study of them can enhance faith (1 mark). Through the Gospels the Kingdom of God is revealed (1 mark). Gives guidance on how to worship (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

The Kingdom of God is anywhere that God's rule is followed and God's work is done, so because God is good/knows best it will make the world a better place (2 mark). For some the Kingdom of God is fulfilled in heaven, so it gives hope of something good after death (1 mark) eg God's presence is enjoyed for eternity (1 mark). In the Kingdom of God, Christians have a healed/restored relationship with God (1 mark). The Kingdom of God is central to Jesus' teachings, within the bible the parables and the miracles all teach Christians about the Kingdom of God (1 mark). Examples from parables such as 'The Lost Son (1 mark), 'The Good Samaritan (1 mark). Miracles - such as Jesus healing the Roman Soldier's servant (1 mark), Jesus restoring the sight of a blind beggar (1 mark). In the Kingdom of God people love their neighbours, so it is of benefit to the both Christians and the people they are helping, eg through acts of compassion (2 marks). Love of enemies helps to heal a divided world (1 mark). The Kingdom of God welcomes the outcast and those who are marginalised in society enabling people to feel loved and included. The Kingdom of God helps people to live with integrity because it is about having the right attitude, not just doing the right actions (1 mark) eg don't just refrain from killing - get rid of hate (1 mark).

Where the point is developed, eg by offering further detail, supporting quotation/source, additional explanation or example, award an additional mark. A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Prayer - Prayer may be alone or may be with other Christians within a church (1 mark). Prayer may be the Lord's Prayer that Jesus taught (1 mark) or may be a personal prayer (1 mark). Prayer gives thanks and praise to God (1 mark), can include confession (1 mark) and can ask for something such as strength of faith (1 mark) or the safety of others who are going through a difficult time (1 mark). Song/music - Christians praise God through the singing of hymns (1 mark). They may be part of a choir (1 mark). The music may be traditional or modern (1 mark), the focus is on praising God (1 mark). They may contain teachings of Jesus (1 mark) or contain information about Jesus' life (1 mark), or be more personal and address God/Jesus giving thanks (1 mark). Eucharist - The last supper is remembered (1 mark) and Christians are reminded of the sacrifice of Jesus (1 mark). They will sip wine which represents/becomes the blood of Christ (1 mark) and take a small piece of bread/wafer which represents/becomes the body of Christ (1 mark). Reading biblical passages (1 mark), this can be done in church services (1 mark), or as part of a bible study (1 mark), or alone in quiet contemplation (1 mark). Putting those teachings into action (1 mark). Attending and participating in church events (1 mark). Can involve many forms of worship such as listening to sermons (1 mark). Accept reference to worship as part of rites of passage (1 mark). Worship during festivals such as Christmas or Easter could also be included. Award marks for any other valid point, in accordance with General Marking Instructions. Max. 3 marks if only one way is described.

No marks for simply stating a personal opinion in evaluation questions. Marks should be awarded for reasons. KU used to support an evaluative point should be credited. 		Responses could include: Yes When you worship God you are showing Him that you are serious about being a Christian (1 mark). Going to church shows you are associating yourself with other Christians/ Christianity (1 mark). Worshipping in church takes effort and commitment - a sign to others that your faith is real (2 marks). Showing love for God and each other within a Christian community is a sign of faith to others (1 mark), eg in the sharing of "The Peace" (1 mark). Jesus said people "This is how people will know you are my disciples, by the love you have for each other." (2 marks). During formal worship there are opportunities to declare your faith (1 mark), eg in recitation of the creed, confession, prayers and hymns (1 mark). No Worship is about your personal relationship with God - not about others (1 mark). The Kingdom of God happens when people show love to those outside the community of faith (1 mark) (Additional marks available for examples ways in which Christian can love today's "outcasts"). Story of the Sheep and the Goats suggests the true sign of real faith is love for others who are struggling (1 mark). You need both social concern and time for worship because being a Christian is about your relationship with God and others (2 marks). Loving others is more important than being very spiritual (1 mark) - St Paul wrote "Without love, I am nothing" (1 mark).

1.	 Award 1 mark for a clear and relevant statement, description, reason or explanation. Where the point is developed, eg by offering further detail, additional explanation or example, award a second mark. A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Responses could include: The stories reveal the nature/greatness of Brahman (1 mark). The stories reveal different aspects of Brahman (1 mark) and this makes Brahman knowable (1 mark). In the Bhagavad Gita Krishna explains the importance of dharma (1 mark) and reveals the true nature of Brahman (1 mark). Stories about the gods are inspirational/motivational (1 mark) eg Rama's quest to rescue Sita demonstrates his love for Sita (1 mark) and the importance he attaches to his dharma (1mark). Stories about the gods are fun (1 mark) eg Krishna's antics with the gopis are naughty and amusing (1 mark). As such the stories are accessible (1 mark) and encourage devotion (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

This affords clarity (1 mark). Ashramas give structure to life (1 mark). Dharma creates clearly defined roles within society (1 mark). These designated roles allow society to function (1 mark) in a way that reflects a divine order (1 mark). Dharma promotes good religious/moral behaviours (1 mark) that generate good karma (1 mark) and better rebirths (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

A maximum of 1 mark should be awarded for an unexplained list. 		 Responses could include: Moksha means liberation (1 mark). Moksha is the final stage of existence (1 mark). Moksha is the end of/freedom from the samsaric cycle (1 mark), the end of successive births, deaths and rebirths (1 mark). Moksha is the ultimate goal of all Hindus (1 mark). Moksha is union with Brahman (1 mark). Moksha means that the atman is reunited with Brahman (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

Marks should be awarded for reasons. KU used to support an evaluative point should be credited. 		 Responses could include: Yes Bhakti-marga can readily be integrated into everyday life through puja (1 mark) or simply by making an effort to remember/be mindful of the divine in daily life (1 mark). Hindus can choose an ishvara/ishtadeva (1 mark) to worship as a murti (1 mark) during puja. This gives puja and bhakti greater personal resonance (1 mark). Bhakti includes simple/quick acts of devotion (1 mark) eg awakening the murti (1 mark). Bhakti can happen through any act of love - to family/friends (1 mark). Bhakti ignores caste barriers (1 mark) so appeals to Hindus forbidden to read the scriptures (1 mark). The Jnana and Karma paths require a level of detachment and concentration which is very difficult to achieve in a world full of distractions and attachment to material things (2 marks). No Bhakti still requires time and effort or mindfulness (1 mark), this is difficult in an increasingly busy/secularised world (1 mark). Other paths might be better suited to people of particular temperaments or talents (1 mark). For example, naturally selfless people might find it easier to follow karma-marga (1 mark). Can be difficult for low caste Hindus to gain access into temple (1 mark). A Brahmin or Sannyasin's circumstances would be well suited to the Jnana path (1 mark) as they are well versed in the Vedas and can remove themselves from life's distractions (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 It is the word of Allah (1 mark) delivered to humanity by the Prophet Muhammad (1 mark). Max. 2 marks for telling the story of the giving of the Qur'an. It is one of the six articles of iman (faith) (1 mark), unchanging and unchangeable, so for all time (1 mark). It is the last and complete book of guidance from Allah - the final revelation (1 mark). Provides information about Muhammad (1 mark) who is the perfect role model on which to base your life as a Muslim (1 mark). It offers moral guidance and how to live on the right path (1 mark). It sets out the Five Pillars of Islam (1 mark). It is the primary source of Shariah/Islamic Law (1 mark) including laws on inheritance, marriage etc (1 mark). Gives Muslims knowledge of their history (1 mark) and the other Prophets of Islam (1 mark). Offers the promise of Paradise or the pain of Hell/al-Jahannum (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Allah is above all other things - school, family, friends etc (1 mark). The declaration of Faith (Shahadah) requires a commitment to submission to the will of Allah (1 mark). Achieving submission is the reason for the Pillars so without it they are meaningless (1 mark). Submission is the way to gain access to Paradise (al Jannah) on Judgement Day (1 mark). They are following the example of the Prophet Muhammad who is a role model for Muslims (1 mark). It is a way of avoiding 'shirk'/idolatry (1 mark) which is the unforgivable sin (1 mark). Allah is creator of all things including humanity itself (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

A very well developed point may be awarded up to 4 marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Every human created by Allah (1 mark). The pinnacle of creation (1 mark), higher even than the angels (1 mark) due to the fact that humans were given the gift of free will (1 mark). Every person has a 'rouh' or soul (1 mark) and a 'fitrah' or moral compass/ conscience (1 mark). Every person is unique (1 mark) and is equal in the eyes of Allah (1 mark). Everyone has the ability to reason (1 mark). Everyone can experience suffering (1 mark) as a result of Adam and Hawwah eating from the forbidden tree (1 mark) and should show patience in the face of suffering (sabr) (1 mark). Everyone has the capacity to sin (1 mark) and this life is a test (1 mark) on which we will be judged by Allah on the Day of Judgement (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

No marks for simply stating an opinion in evaluation questions. Marks should be awarded for reasons. KU used to support an evaluative point should be credited. 		 Yes There are too many pressures in western society which make submitting to Allah unfeasible (1 mark), eg work hours, focus on materialism (1 mark). It is inappropriate to try and encourage others to become Muslims in a society which endorses religious diversity (2 marks). Modern societies are frequently governed by secular laws so it is no longer relevant to try and promulgate Allah's divine laws here on earth (2 marks). There is no direct contact with angels in today's society, so we cannot be confident we are being good vice-regents anyway (2 marks). No It is never too difficult to follow the example of the Prophet Muhammad (1 mark), regardless of when and where you live (1 mark). You don't have to proselytise to live as Allah's vice-regent (1 mark), you just need to show your faith in (and submission to) Allah (1 mark). It is a requirement of every Muslim, even though it may not be easy at times (1 mark). It is part of Allah's test for us, and if we fail in this, we will go to al-Jahannum in the afterlife (2 marks). Award marks for any other valid point, in accordance with General Marking Instructions.

Section 1, Part E: Judaism

Where the point is developed, eg by offering further detail, supporting quotation/source, additional explanation or example, award an additional mark. A very well developed point may be awarded full marks. A maximum of 1 mark should be awarded for an unexplained list. 		 Believed by some to be God's words given to Moses (1 mark), therefore completely trustworthy (1 mark). Contains God's commandments which Jews must follow (1 mark) as their part of the Covenant agreement (1 mark). If they follow God's commandments he will look after them (1 mark). Tells Jews about important events in their history (1 mark), for eg the calling of Abraham, escape from slavery in Egypt, giving of the law, wandering in the wilderness etc (1 mark). Teaches Jews about the nature of God (1 mark) eg created the world and people, cares for his creatures, a unity or "One" (1 mark). Gives precise instructions on how to worship (1 mark) and celebrate festivals like Passover (1 mark). Award marks for any other valid point, in accordance with General Marking Instructions.

The Chandogya Upanishad 3:19: 1-4 talks about the world emerging from an egg (1 mark). These things symbolise ideas like order coming out of chaos (1 mark).

Holy scriptures promise reward for obeying/punishment for disobeying God's commands (1 mark). Freewill means we have to bear responsibility for the consequences of our bad decisions (1 mark). Some "Natural disasters" can be seen to have human causes, eg Climate Change is a result of failure to reduce Carbon Dioxide in the atmosphere (2 marks). If a person believes that God's nature means he is omnipotent, immanent, interventionist, they should expect Him to intervene in the world (2 marks). A miracle would require God to break the laws of nature which he established. This would mean going against his own nature/plan (2 marks). You can't have a world in which the laws of physics are suspended every time someone might get hurt because it would result in chaos (2 marks). Perhaps better to see the order and predictability of the universe as the miracle, rather than any violation of these laws by God (2 marks).
